#### PRESIDENTS OPENING

Meeting called to Order at 700pm by NHF

We have a quorum of 94 people – 48 proxies and 46 signed in person. 37% of the community.

Call for additional Board member by NHF – looking for more members to add depth to the board. Current board terms up all at same time

Discussed getting documents together for a homeowner

Discussed 4800 bill for stump removal from previous admin we inherited

Pay off attorney for 10000 instead of 17000

Discussed signed snow contract when board took over – had no contract and no one would sign with us. That contractor that signed was on an annual basis. Zilke came in to help D+K

2015 and 2016 audits came out great

Needed attorney counsel for XXXX – got distracted

Board member insurance was cancelled by current carrier – contacted three different companies for quotes. We cant be making decisions without insurance. Most turned us down – lawsuit spending was over 100,000 protecting us. Currently under appeal.

Also threatened by a homeowner to do something a certain way or be sued. Insurance company opened as a claim. But not a real claim. 9600 with a 35000 deductible.

Looking forward to improvements this year – had no budget from getting organized.

Money in budget for trees, mailboxes and other concerns we can go over.

Vidolich says that we can only have 5 people max – Michigan corporation (condominium) act, specifically not for profit organizations. Need to have staggered terms. Nancy explains that john Gray stayed until his term and left.

Dave Algase – board shall consist of 5 members, but terms do not have to be staggered, just two year terms – can appoint an eligible co-owner to fill board if necessary.

Can have one person step down, new person fills and then step down person is reappointed for two years. Reappointee can resign, just like anyone else.

Susan Beyer steps down from the board. Nancy nominates Susan Beyer to the board. Susan accepts.
